1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

These financial statements have therefore been prepared as special purpose financial statements prepared solely to meet the Associations Incorporations Act 1981 requirements to prepare financial statements as Management believe there are no general purpose users of the financial statements. Therefore the statements do not comply with all Australian Accounting Standards applicable to general purpose financial statements. The following Australian Accounting Standards have been applied:

The financial statements are prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following is a summary of the material accounting policies adopted by the association in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Membership receipts are brought to account on an accruals basis.

Depreciation of Fixed Assets

All assets are depreciated over their estimated useful lives using the diminishing value method. Profits and losses on disposal of property, plant and equipment are taken into account in determining the profit for the year.


